FINANCIALS 2022 – Arindam Chakravarty

- Arindam presented the financials for last year and confirmed that NASKA has ended with surplus.
- 2022 starting balance at bank was: \$32,722.35, and we ended the year with net bank balance of \$38,303.83
- Total collections for the year was \$28,444.21, total expenses at: \$22,862.73 vs a planned budget of \$29,343.00
- For this year, expenses for cultural event and community hall booking, were lower than budgeted. On the other hand, collection from vendors and sponsors (ads) has reduced.
- As per decision taken by the current EC, a fixed deposit of \$20,000.00 has been set aside from the available surplus, with the remaining amount being available for emergency requirements, if any.
